First through Fourth placement ribbons awarded for A-Level Regular classes in each of the three height divisions. First through Fourth placement ribbons awarded for B-Level Regular classes regardless of height. Special awards will be offered at this event.

### **Entry fees & Limits**

**Pre-Entry:** Instinct \$10, Novice, Open \$20, Senior, Master, Crazy 8's \$25.

**ADD \$5 for Late Entries.** Late entries are not guaranteed entry to trial and will be accepted only up to Judging Limits. Confirmations will not be sent for late entries.

Per Barn Hunt rules Judges are limited to 8 hours of judging and a maximum run value. The club will limit entries accordingly.

### **Refund Policy**

Refunds will be given for injured or deceased dogs with written notification to the test Chair with an accompanying note from a veterinarian. ### **Participant Information**

Please consult the current rules at barnhunt.com for entry and trial information. Smoking is NOT ALLOWED unless you are in your vehicle. No concessions are provided at the event. **No water or snacks will be provided.** This event is outdoors on private property. Rings are accessible to the disabled, however, the portable toilet is not. Plan to work from your vehicle. Participants are required to follow all instructions given in the briefing regarding areas where dogs are allowed. Parking will be along a private road. **BHA COVID Rules are in effect and will be strictly enforced**

### **Description of the trial ring and blind area (all on grass)**

The blind area is outdoors under a canopy tent at least 10 by 15 between 20 and 40 feet of the ring. The ring is on grass/dirt under cover.
